4. *That the objection given by the appellant in his present appeal at Sr. No. 1 (i), (ii), (iii) & (iv) are totally vague and baseless. PIO while abiding the orders of First Appellant Authority had already supplied the information asked by the appellant at Sr. No. 1 of his RTI application. The information as received from concerned branch was supplied to the appellant free of cost. So, the reply respondent is not any fault for not providing the information to appellant in regard to Sr. No. 1 as depicted by appellant.*
5. *That the objection of appellant that the information with regard to Sr. No. 2 to Sr. No. 4 of his RTI application is covered under section 2(f) of RTI Act, 2005 and is not exempted under section 8(1) (d) of the Act is not sustainable. At Sr. No. 2 of his RTI application the appellant has asked about model answer sheet used to evaluate, at Sr. No. 3 he has asked about time and place where answer sheets were inspected and at Sr. No. 4 he has asked about the name of guide provided to evaluator. All these points are correlated and are directly in relation to the information which is confidential in nature and if such information is disclosed publically that would definitely unveil the secrecy of examination and evaluation process of University and would also endanger the life and physical safety of person involved such examination/evaluation process."*

In view of the aforementioned facts, no further cause of action required in this case, hence the Appeal Case is **Disposed Off and Closed**. Copies of the order be sent to the parties.
