The representative of respondents states in the court that the sought for information has already been supplied to the appellant by concerned PIOs through registered post ; Dhuri on 11-04-2018, Sangrur on 11-10-2018 and Barnala on 08-10-2018.

2. The appellant is not present in the court. However, an e-mail is received in the Commission office from the appellant in which he has stated that no information has been supplied to him till date.

3. The respondents are directed to send the information again by registered post before the next date of hearing.

4. The appellant is directed to be present in the court on the next date of hearing.
