3. The Appellant states that the information has not been provided to him till date. He has also filed his submissions in this regard vide commission diary no. 6222 dated 18.03.2021. Copy of the same is taken on record.
4. No one has appeared on behalf of the Respondent today.
5. This is the first date of hearing and no one has appeared on behalf of the Respondent today.
