Mrs. Harkesh Kaur Lottey, has requested to supply the information as enumerated in her RTI dated 28.01.2019 to the PIO o/o DPI(EE) Punjab, Mohali. On getting no information from PIO, she filed her RTI application to the First Appellate Authority on 06-03-2019 and when getting no information from him, she filed his appeal under Section 19(1) of RTI Act 2005 in the Commission on 13.05.2019.

2. The appellant is present in the court who states that the sought for information has not been supplied by the respondents till date.

3. The representatives of the respondents bring the sought for information in the court and the same is handed over to the appellant.

4. After going through the supplied information the appellant states that the information is incomplete.

5. The representatives of the respondents are directed to supply the complete information to the appellant within 10 days by registered post under intimation to the Commission. They are further directed to be present in the court along with a copy of the supplied information on the next date of hearing.

4. The appellant is directed to point out deficiencies, if any, in the supplied information in writing to the respondents under intimation to the Commission.
