ORDER

Shri Amarjit Singh Dhamotia, appellant filed RTI application dated 11.02.2021 and sought some information from the SPIO, O/o Police Commissioner, Ludhiana. When no information was provided to him by the SPIO, then he filed First Appeal before the First Appellate Authority on 23.03.2021 and then Second Appeal before the Punjab State Information Commission on 17.05.2021. The case was registered and allocated to the Bench. Notice of hearing was issued to both the parties for today through **CISCO Webex Meetings Software**.

Shri Gurmej Lal is present on behalf of Shri Amarjit Singh Dhamotia, appellant and he stated that the sought for information has not been provided by the SPIO till date.

ASI Tarsem Lal, who is present on behalf of the SPIO stated that the investigation regarding the information sought by the appellant is still pending before the ACP (South), Ludhiana, so the information cannot be provided to the appellant U/s 8(1)(h) of the RTI Act, 2005. He further stated that the reply regarding this has already been sent to the appellant vide letter no.121-FA dated 19.04.2021 and now again vide letter dated 23.08.2021.

The Commission has received an e-mail sent by the SPIO, which is a copy of letter no.647-D dated 23.08.2021 along with a copy of letter no.121-FA dated 19.04.2021. I have gone through the said letters and the above mentioned facts have been submitted by the SPIO.

As the investigation regarding the information sought by the appellant is still pending, so the information cannot be provided to the appellant U/s 8(1)(h) of the RTI Act, 2005. Hence the present appeal case is **disposed of and closed** with the direction to the SPIO that whenever the investigation in the concerned case will be completed, the attested copies of the sought for information be sent to the appellant through registered post within 10 days and compliance report be sent back to the Commission.
