ORDER

This order may be read with reference to the previous order dated 24.2.2021 vide which the case was adjourned for 5.4.2021 but due to administrative reasons the case was further adjourned for 29.4.2021 and further adjourned for today i.e. 3.6.2021.

2. The respondent-Public Information Officer-cum-Block Development and Panchayats Officer filed the specific undertaking with regard to the sought information, which is reproduced below:-

She has also sent the orders of the Deputy Commissioner, Mansa to dissolve the Baba Jogi Pir Trust and handing over the same to the Gram Panchayat Ralla, which is taken on record.

3. Accordingly, a copy of the same is sent to the appellant during the course of hearing and after going through the same the appellant requested for the next date of hearing at Chandigarh.

ORDER
