4. Sh. Sukhwinder Singh, Jr. Engineer appears on behalf of the Respondent- PIO and states that the requisite information has already been supplied to the appellant by hand and he has received the same vide dated: 28.06.2019.

5. After perusal of the case file, it is observed that the Respondent – PIO has provided the requisite information to the Appellant by hand and after that no observation has been received from him. As the Appellant is absent and nothing has been heard from him regarding the receipt of information, it is presumed that he is satisfied with the information provided. No further action is required. Hence this Appeal Case is **closed and disposed off**. Copies of the order be sent to the parties.
