He may take a note that in case he does not file his written reply and does not avail himself of the opportunity of personal hearing on the next date, it will be presumed that he has nothing to say and the Commission will proceed ex-parte.

6. The respondent PIO is also directed to file the reply/supply the information on the next date of hearing.

7. With this, the case is **adjourned to 23rd May, 2024 at 11:30 A. M. for hearing.**
