2. Today the complainant states that no information has been given to him so far.

3. Respondent Sh. Harpreet Singh, Computer operator appeared on behalf of the respondent and states that he has brought the information today in the Commission. He further states that the amount of penalty has already been deposited in the Treasury.

4. The perusal of the file shows that during the last hearing dated 03.06.2019, Sh. Vikram , Naib Tehsildar was directed to come present, but today he is not present. This shows that he has no regard for the orders issued by the Commission. Such kind of behavior of a Government servant needs to be condemned and such employees need to be taught a good lesson so that rest of the employees have a right kind of message to wake up and perform their duties under the RTI Act for ensuring complete transparency and due accountability in the governance affairs of the public authorities.

5. Moreover it is observed that respondents are being represented by very low level officials. From the next date of hearing, no person below the PIO will be allowed to appear in the Commission. Appearance of low level officials will amount to disrespect to the RTI Act besides invoking the provisions of imposition of penalty and also recommendation of disciplinary action against the PIO under Section 20 of RTI Act, 2005.
