After going through the case file, it has been observed that an email dated 13.10.2020 has been received from the Appellant's side in which he has written that the information which he has received in AC:399 / 2020 on dated 12.10.2020 is incomplete and misleading in nature and only 10% to 15% of information has been supplied to him.

In view of above, on the last hearing, dated 13.10.2020 last and final opportunity was given to the Appellant for pointing out the deficiencies (point wise) within a week to the Respondent / PIO as well as to the Commission, **but he failed to do so.**

Furthermore, since he has not sent any letter mentioning deficiencies to the PIO or to the Commission. It appears that the Appellant has no intension of collecting the information and he is just lingering the case by not pointing out the deficiencies particularly.

So, no further intervention is required in this case. **This case is disposed of and closed.**
