ORDER

- 1. The RTI application is dated 27.08.2020 vide which the Complainant has sought information as enumerated in his RTI application. The complaint was filed by the complainant in the Commission on 21.09.2020 under Section 18 of the Right to Information Act, 2005 (hereinafter RTI Act).
- 2. Notice of hearing was issued to the parties for 05.01.2020 by the Commission through V.C. in D.C. Office, Ludhiana. As such, the complaint case has been heard today through V.C. in DC Office, Ludhiana.
- 3. Shri Gurjit Singh Jagpal comes present to attend the hearing through V.C. He states that incomplete information has been supplied to him and he is not satisfied with the same.

He states that with regard to the information sought by the complainant, an enquiry is being conducted by the Vigilance Department, Punjab which has not been finalized as yet. 5. Post deliberations with the representative of PIO and perusal of case file, it is ascertained that the complainant has not availed the provision of the Section 19(1) of the RTI Act by filing an appeal with the First Appellate Authority (FAA). As such, the FAA has not been able to address the grievances of the complainant. On enquiring from the PIO, he states that Smt. Daljit Kaur, Additional Director is the First Appellant Authority.

- 6. It must be noted that there is an alternate and efficacious remedy of First Appeal available under Section 19(1) of the RTI Act. It appears that the complainant has failed to avail the same in the instant complaint case. The Bench observes that the complainant must be given an opportunity to avail of the above said remedy.
- In view of the aforesaid, the instant matter is remanded to the First Appellate Authority i.e. Smt. Daljit Kaur, Additional Director, O/o Director, Technical Education & Industrial Training, Punjab, Chandigarh. The Commission hereby directs the FAA to treat the copy of the Complaint (enclosed herewith) as the First Appeal and decide the matter in accordance with the provisions of the RTI Act after giving all concerned parties an opportunity to be heard. In case, the complainant is not satisfied with the decision of the First Appellate Authority (FAA), he is at liberty to file second appeal with Punjab State Information Commission in accordance with the provisions of the RTI Act, 2005.
- 8. In view of the above, **the case is disposed off and closed.** Copy of the order be sent to the parties.
