4. In view of the same, no further cause of action is left. Hence, the Complaint case filed by the Complainant is **disposed off and closed**. Copy of the orders be sent to the parties.

ORDER

This order may be read with reference to the previous order dated 11.02.2020.

2. The Appellant states that he has not received the complete information till date. Further, he states that as directed in the previous hearing, he had gone to inspect the record in the office of the Respondent but the record was not shows to him

3. After perusing the file, it is ascertained that no information has been given to the appellant so far. The appellant filed RTI with the PIO, O/o Co-operative Societies, Bathinda on 16.10.2018, but till today no information has been given to him. Further, the Appellant was directed to inspect the record in the office of the Respondent but the record was not shown to him. This clearly shows that the Respondent has no regard for the orders issued by the Commission. This is indeed a serious matter.

4. This has resulted in much avoidable inconvenience and hardship to the Appellant. He is, therefore, entitled to be compensated under Section 19(8)(b) of RTI Act 2005 for the loss and detriment suffered by him. In the circumstances, I am of the view that ends of
