The appellant through RTI application dated 14.03.2019 has sought information regarding Hill View-3 Area-0.33 Acre, Sunny Enclave, Rakha Jhungian, Kharar comprising CLU, total fee, NOC and other information concerning the office of MC Kharar. The appellant was not provided the information after which the appellant filed a first appeal before the First Appellate Authority on 06.05.2019 which took no decision on the appeal.

The respondent present pleaded that the information was sent to the appellant vide letter dated 27.05.2019. However, the appellant was not satisfied. The respondent has again brought the complete information and has submitted a copy of the same to the Commission. The appellant is absent.

I have gone through the RTI application and the information provided by the PIO and find that the information has been provided to the best possible extent. A copy of the information is being enclosed with the order for the appellant.

No further course of action is required. The case is disposed off and closed.
