ORDER

This order may be read with the previous order dated 19.11.2019.

2. The brief of the case is that the appellant has sought the information pertaining to the Village Khalil from the Public Information Officer o/o Block Development and Panchayats Officer, Nadala, District Kapurthala.

3. As per his 2nd appeal the case was fixed for hearing on 27.8.2019 then on 4.9.2019, 30.9.2019, 14.10.2019 and was last heard on 19.11.2019. But the appellant never attended the hearing from the initial stage. On 19.11.2019 an email has been received on behalf of the appellant in which Shri Ranjit Singh has been authorized to defend the appeal cases pending in the Commission. Accordingly, on 19.11.2019, an email has been received from Shri Ranjit Singh that he is not physically fit due to illness and will not attend the court and requested for another date. As per the request of the representative of the appellant a reply of the email was sent on 10.12.2019 that "in case he is well, please inform the Commission so that the next date be fixed please" but getting no response from the representative of the appellant. Similar email was sent by the Commission to the representative of the appellant on 6.1.2020 and 6.2.2020 even though getting no response from him.

However, the liberty is granted to the appellant to approach the Commission within 15 days from the issue of this order in case he wants to pursue the same.
