He should take appropriate action on RTI application and send reply to the appellant with a copy to the Commission.

This order may be read with reference to the previous order dated 02.09.2019 vide which the respondents were directed to supply statement from 1.1.2015 to 30.04.2015 of HDFC Bank.

2. In response to the previous order, the respondents have sent a copy of complete statement from the date of opening of account in HDFC Bank till date, to the appellant with a copy of the same through e-mail to the Commission. With supply of this statement, complete information has been supplied to the appellant and nothing has been kept pending which could be supplied to the appellant, who is satisfied. Hence, the present case is **disposed of** and **closed**. Copy of the order be sent to the parties.
