### ORDER

This order may be read with reference to the previous order dated 04.10.2018 vide which viewing the callous and lackadaisical attitude of the PIO seriously, last opportunity is afforded to the PIO to file reply to the notice dated 18.06.2018 issued by the Commission and supply information to the complainant before the next date of hearing, failing which punitive action under the provisions of RTI Act, 2005 will be initiated against him.

2. The representative of the respondent-PIO places written reply dated 4.11.2018 on record of the case file, the contents of which are reproduced below:-

4. The representative of respondents states that there were Service Rules 2007 but those were quashed by the Hon'ble Punjab and Haryana High Court in 2012. Again they made another set of rules in 2013 in the shape of draft rules and correspondence is going on with the government and Punjab Vidhan Sabha. Government suggested some amendments, which were incorporated in the said draft rules and again sent to the Government for notification.

5. After hearing the representative of the respondents and going through the record available on the case file, it is revealed that recruitments have been made under the existing draft rules though they are not notified and they are under process. But since the rules are in operation and the recruitments are taking place under those very rules. Copy of the same should be uploaded on the website of the public authority and made available to the appellant. There is nothing which can prevent the authorities, not to put these draft rules in the public domain, especially, when they are in operation. Also the drafts rules are as good as rules, if the regular rules are not available. The respondents are directed to upload draft rules on the website of Punjab Vidhan Sabha. With these observations, the instant case is **disposed of** and **closed**. Copies of the orders be sent to the parties.

### ORDER

This order may be read with reference to the previous order dated 04.10.2018 vide which the respondents were directed to send specific reply with inquiry report. He was further directed to produce original record on 6.11.2018.

2. Shri Mandeep Singh Dhillon, Tehsildar, Ludhiana (East) is appearing on behalf of the respondents and produces letter dated 5.11.2018, the contents of which are reproduced below:-

ਸੰਬੰਧਤ ਪਟਵਾਰੀ ਹਲਕਾ ਨੂੰ ਬੁਲਾਇਆ ਗਿਆ। ਪਟਵਾਰੀ ਹਲਕਾ ਨੇ ਹਾਜ਼ਰ ਅਦਾਲਤ ਆ ਕੇ ਆਪਣੇ ਬਿਆਨ ਕਲਮਬੰਦ ਕਰਵਾਏ ਕਿ ਉਹ ਹਾਲ ਹਲਕਾ ਢੋਲੇਵਾਲ ਵਿਖੇ ਤਾਇਨਾਤ ਹੈ। ਪਹਿਲਾਂ ਉਹ ਹਲਕਾ ਤਰਫ ਜ਼ੋਢੇਵਾਲ ਵਿਖੇ ਤਾਇਨਾਤ ਸੀ। ਉਸਨੇ ਡਾ: ਬੀ.ਐਸ.ਸੋਹੀ ਵਾਸੀ ਲੁਧਿਆਣਾ ਦੀ ਦਰਖਾਤ ਦੇਖ ਲਈ ਹੈ। ਡਾ: ਬੀ.ਐਸ.ਸੋਹੀ ਨਾਮ ਦਾ ਵਿਅਕਤੀ ਕਦੇ ਉਸ ਦੇ ਪਾਸ ਕਦੇ ਵੀ ਕਿਸੇ ਕੰਮ ਲਈ ਪਟਵਾਰ ਦਫ਼ਤਰ ਹਾਜ਼ਰ ਨਹੀਂ ਆਇਆ ਅਤੇ ਲਾਂ ਹੀ ਉਹ ਉਸ ਨੂੰ ਜਾਣਦਾ ਹੈ। (ਅਨੁਲਗ ਹ)

ਇਸ ਤੋਂ ਇਲਾਵਾ ਤਹਿਸੀਲਦਾਰ ਲੁਧਿਆਣਾ ਪੂਰਬੀ ਨੇ ਆਪਣੀ ਰਿਪੋਰਟ ਵਿਚ ਲਿਖਿਆ ਕਿ ਉਹਨਾਂ ਵਲੋਂ ਨਿੱਜੀ ਤੌਰ ਤੇ ਆਪਣੇ ਫੋਨ ਨੰਬਰ (98727-68606) ਤੋਂ ਫੋਨ ਨੰਬਰ (99886-01845) ਮਿਤੀ 2.11.2018 ਅਤੇ ਮਿਤੀ 3.11.2018 ਨੂੰ ਗਲ ਕੀਤੀ ਗਈ। ਪਰ ਪ੍ਰਾਰਥੀ ਫਿਰ ਵੀ ਹਾਜ਼ਰ ਨਹੀਂ ਆਇਆ। ਉਹਨਾਂ ਵਲੋਂ ਆਪਣੀ ਰਿਪੋਰਟ (ਅਨੁਲਗ ਕ) ਤੇ ਸ਼ਾਮਲ ਹੈ।

ਕਿਸ ਅਫ਼ਸਰ ਕੋਲ ਪੈਂਡਿੰਗ ਹੈ ਅਤੇ ਨਾਂ ਹੀ ਉਸ ਨੇ ਇਹ ਲਿਖਿਆ ਹੈ ਕਿ ਪਟਵਾਰੀ ਨੇ ਕਿਸ ਕੰਮ ਲਈ ਪੈਸਿਆ ਦੀ ਮੰਗ ਕੀਤੀ ਹੈ। ਅਜਿਹੇ ਵਿਚ ਪ੍ਰਾਰਥੀ ਨੂੰ ਬਿਨਾਂ ਸੁਣੇ ਇੰਨਕੁਆਰੀ ਕਰਨਾ ਸੰਭਵ ਨਹੀਂ ਜਾਪਦਾ ਹੈ।
