Both the parties are present today.

The respondent stated that in compliance to the Order dated 17.11.2020 passed by the Commission, the complete information along with cheque of Rs.3,000/- as compensation has been sent to the appellant through registered post on 04.01.2021 and a copy of the same has also been sent to the Commission as compliance.

The Commission has received an e-mail sent by the SHO, Police Station, Jodhewal, Ludhiana, which is a copy of letter dated 04.01.2021 along with photocopy of cheque no.240360 dated 01.01.2021 amounting to Rs.3,000/- in favour of Smt. Anita Kiran, appellant.

The appellant stated that she has received the information and the cheque of compensation of Rs. 3,000/- sent by the SPIO. She further stated that she is satisfied with the information and also requested to dispose of her appeal case.

As the SPIO has resolved the matter involved in the RTI application and provided the complete information and also paid the amount of compensation to the appellant and the appellant herself admitted that she is satisfied with the information, so the present appeal case is **disposed of and closed.**
