## ORDER

The RTI application is dated 30.6.2020 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter called FAA) on 25.7.2020 and second appeal was filed in the Commission on 5.10.2020 under Section 19 of the Right to Information Act, 2005 (hereinafter called RTI Act). Notice of hearing was issued to the parties for today.

2. The appellant has sought the following information:-

3. The appellant states that he has received the complete information and has no objection, if the case is closed. Also the respondents have placed on record a copy of the information so supplied to the appellant, which is taken on record.

4. Since, the complete information has already been supplied to the appellant as per the submissions made by him, therefore, the Commission opines that no further action is required in this case. Hence, the case is disposed of and closed.

## ORDER

The RTI application is dated 21.9.2020 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter called FAA) on 25.9.2020 and second appeal was filed in the Commission on 8.10.2020 under Section 19 of the Right to Information Act, 2005 (hereinafter called RTI Act). Notice of hearing was issued to the parties for today.

2. The appellant has sought the following information:-

“ ਮੇਰੇ ਵੱਲੋਂ ਇੱਕ ਬੇਨਤੀ ਪੱਤਰ ਰਜਿਸਟਰਡ ਡਾਕ ਦੁਆਰਾ ਮਿਤੀ 7.9.2020 ਨੂੰ ਮਹਾਮੁਹਿਮ ਰਾਜਪਾਲ ਪੰਜਾਬ ਜੀ, ਰਾਜਪਾਲ ਭਵਨ ਪੰਜਾਬ, ਪੰਜਾਬ ਸਰਕਾਰ, ਚੰਡੀਗੜ੍ਹ ਨੂੰ ਭੇਜੀ ਸੀ। ਮੇਰੀ ਬੇਨਤੀ ਪੱਤਰ ਤੇ ਆਪ ਜੀ ਵੱਲੋਂ ਜਾਂ ਸਬੰਧਿਤ ਵਿਭਾਗ ਵੱਲੋਂ ਕੀਤੀ ਗਈ ਮੁਕੰਮਲ ਕਾਰਵਾਈ ਤੇ ਦਫਤਰੀ ਨੋਟਿੰਗ ਦੀ ਤਸਦੀਕਸੁਦਾ ਕਾਪੀ ਦਿੱਤੀ ਜਾਵੇ।”

3. The appellant has sent an email dated 6.1.2021 vide which it has been requested to club the Appeal Case No. 3113/2020 and Appeal Case No. 2958/2020. Also the sought information, appellant and the respondent authority remained the same, therefore, the cases are clubbed as the sought information relates to the financial help for the education of his son who is studying at Chandigarh University, Gharuan.

4. The Public Information Officer o/o the Hon'ble Governor of Punjab made the submissions which has already been received in the Commission at Diary No. 19097 dated 24.12.2020, which are taken on record.

5. Also a reply has been received from the Chandigarh University, Gharuan and has intimated that the issue regarding fees of the son of Sh. Jasbir Singh has been resolved and the said letter was sent to the appellant. The appellant has also filed the similar applications to various authorities and filed the 2<sup>nd</sup> appeal in these cases that too have been disposed by the Commission i.e. Appeal Case(s) No. 2887 of 2020, Appeal Case No. 2888 of 2020, Appeal Case No. 2529 of 2020, Appeal Case No. 2585 of 2020 and Appeal Case No. 2588 of 2020.

6. The appellant states that he is a tax payer from the last 20-25 years and belongs to the middle class family so he requests that the directions may be issued to the respondent departments to extend the financial help to him for the payment of fees of his.

7. Since, the information sought/action taken has already been supplied to the appellant. Therefore, the Commission observes that no further action is required in this case as it is beyond the scope of the provisions of the RTI Act, 2005 to direct the respondent authorities to extend the financial help to the individual/appellant. Hence, the case is disposed of and closed.
