- 5. Kindly provide me certified copy of complete file (cover to cover) of above enquiry as mentioned in news of 32 Employees of Ranjit sagar Dam project, Shahpurkandi whey 32 Employees got sacked (ৰজিবা) under enquiry by Government officials.
- 6. Kindly provide me certified copy of reason of delay if no list/Data has been prepared yet by concerned officials on above mentioned news of 32 Employees of Ranjit sagar Dam project, Shahpurkandi whey 32 Employees got sacked (ৰস্ত্ৰাম্ব) under enquiry by Government officials.

- 2. The appellant is absent without intimation. As directed, at the last Hearing on 27.05.2024, XEN, Powerhouse No.1 and Hydel Channel Division, Shahpur Kandi Township, Sh. Arvind Kumar, is present in person along with Sh. Amit Sahota, XEN and Sh. Sanjay Kumar, Drafts Man. He has submitted a reply, as per Para No.3 of Commission's Order Dated 23.02.2024 vide Letter No. 3151-53 Dated 04.06.2024. Smt. Arvind Kumar, has also submitted a copy of an earlier reply provided to the appellant vide Letter No.1029-30 Dated 23.02.2024, which was provided to the appellant in person, wherein, XEN had clearly stated that Oustee Certificates and Land Acquisition Notices were not obtained from the 32 persons, cited in the RTI application.
