The PIO is directed that the attested copies of remaining information be sent to the appellant through registered post within a week and compliance be sent to the Commission. In case of non compliance of the Order of the Commission, a Show Cause Notice will be issued to the PIO on the next date of hearing.

Both the parties should connect through CISCO WEBEX MEETINGS Software on the next date of hearing i.e. 30.07.2020 at 11:30 A.M.

Present:- Shri Ujjagar Singh, appellant is absent. Inspector Pavittar Singh-979/LDH, PIO-cum-SHO, P.S. Daba, Ludhiana is present.

ORDER

Shri Ujjagar Singh, appellant filed RTI application dated 30.10.2018 and sought some information from the office of the PIO.

Shri Ujjagar Singh, appellant is absent today, however he has sent an e-mail, which is taken in the file of the Commission. The appellant was also absent on the last date of hearing.

Inspector Pavittar Singh-979/LDH, PIO-cum-SHO, P.S. Daba, Ludhiana is present today and he stated that 31 pages of information along with demand draft of Rs.2,000/-, which was awarded in favour of the appellant as compensation, was sent to him.

The appellant has simply submitted in his e-mail that he is not satisfied with the information, but he has not mentioned any specific mode or instance that how the information is not acceptable and he has not mentioned that what are the deficiencies in the information.

Inspector Pavittar Singh-979/LDH, PIO-cum-SHO, P.S. Daba, Ludhiana submitted a copy of postal receipt dated 22.06.2020 through which the information was sent to the appellant. He stated that the information which existed in the office of the public authority has already been sent to the appellant.

A Show Cause Notice was issued to Inspector Pavittar Singh, -979/LDH, PIOcum-SHO, P.S. Daba, Ludhiana that why the information has not been provided to the appellant within the stipulated period and so why you may not be penalized.

#### Appeal Case No. 456 of 2019

Inspector Pavittar Singh, PIO-cum-SHO filed duly signed reply dated 07.07.2020 to the Show Cause Notice, which is taken in the file of the Commission. An opportunity of personal hearing is afforded to Inspector Pavittar Singh.

I have gone through the reply and also gone through the case file. The appellant filed RTI application on 30.10.2018. On the other hand Inspector Pavittar Singh joined as SHOcum-PIO, Police Station, Daba on 16.11.2019. It means that Inspector Pavittar Singh was not the PIO-cum-SHO, P.S. Daba when the present RTI application was filed on 30.10.2018 rather he has joined after a period of 13 months. So, he is not personally liable for the delay in providing the information to the appellant. Hence the Show Cause Notice issued to Inspector Pavittar Singh, PIO-cum-SHO, P.S. Daba is hereby dropped and filed.

As per the facts of the present case, the sought for information comprising of 31 pages was sent to the appellant by the PIO and the appellant has not brought any specific deficiency, if any, to the notice of the PIO. So, the PIO has resolved the matter involved in the RTI application and provided the sought for information to the appellant. Hence the present appeal case is **disposed of and closed**.
