ORDER

This order may be read with reference to the previous order dated 12.11.2020.

2. The representative of the respondents states that the complete information as available on record has already been supplied to the appellant. However, the appellant states that there are ambiguities as he has sought the action taken on the complaint filed by him on 11.5.2020. But the respondent-Public Information Officer states that till date the actual position of the case has been provided to the appellant. He also states that on the said complaint action taken of which has been sought by the appellant, an affidavit has already been sought but he is not submitting the same. Due to which further action to be taken on the matter is held up. The respondent-Public Information Officer also submitted the copy of information supplied to the appellant in this regard, which is taken on record.

3. After hearing the parties and the perusal of the case file, it has transpired that the information as has been sought by the appellant has already been provided. Since, the appellant is not filing the affidavit as has been asked for by the authorities concerned, no further directions can be given in this regard as it is beyond the scope of the provisions of the RTI Act, 2005. 3. The respondent-Public Information Officer states that the complete information has been supplied to the appellant. Also a written submissions have been received from the appellant, which are taken on record, in which it has submitted that he has received the information regarding income and expenditure but he has not received the information regarding illegal possession on the panchayat land.

3. Since, he has not sought the information regarding panchayat land in this case, therefore, the Commission is of the view that no further action is required in this case. Hence, the case is disposed of and closed.

2. The appellant has sought the following information:-

This order may be read with reference to the previous order dated 21.12.2020.

2. The appellant has sought the following information:-

ਅ) ਇਹ ਕਿ ਪਰਾਰਥੀ ਸੁਰਿੰਦਰ ਸਿੰਘ ਵੱਲੋਂ ਮਿਤੀ 09-12-2019 ਨੂੰ ਆਪ ਜੀ ਨੂੰ ਗ੍ਰਾਮ ਪੰਚਾਇਤ ਪਿੰਡ ਪੱਕਾ ਚਿਸਤੀ ਦਾ ਕਾਰਵਾਈ ਰਜਿਸਟਰ ਆਪਣੇ ਕਬਜ਼ੇ ਵਿਚ ਰੱਖਣ ਲਈ ਬਜਰੀਆ ਡਾਕ ਰਾਹੀਂ ਦਰਖਾਸਤ ਦਿੱਤੀ ਸੀ ਉਸ ਦਰਖਾਸਤ ਅਤੇ ਉਸ ਤੇ ਕੀਤੀ ਗਈ ਕਾਰਵਾਈ ਦੀਆਂ ਤਸਦੀਕਸੁਦਾ ਕਾਪੀਆਂ ਦਿੱਤੀਆਂ ਜਾਣ।

3. The appellant states that he has received the information except related to the receipt and dispatch of the proceeding book in the office of the Divisional Deputy Director in accordance with my complaint, action taken of which has been sought. However, the representative of the respondents states that according to the complaint filed by the appellant proceeding book was called for inspection and thereafter the same has been handed over to the custodian of the record on the same day. He further clarified that the proceeding book has never been taken on record in the office of the Divisional Deputy Director. Furthermore, the representative of the respondents states that the complaint filed by the appellant has already been filed.

4. Since, the representative of the respondents given the specific reply as enumerated above so the Commission observes no further action is required to be taken in this case. Hence, the case is disposed of and closed.
