## ORDER

This order may be read with reference to the previous order dated 5.8.2021.

2. The appellant states that no information has been provided by the respondents so far. The appellant also placed on record the copy of her request dated 27.11.2020/No.69 dated 4.12.2020, which is taken on record. However, none was present on behalf of the respondents due to strike by the officials of the respondent authority and the case was adjourned for today i.e. 8.9.2021. Neither the respondent-Public Information Officer is present nor is information being supplied to the appellant. The perusal of the file shows that in this case, application for information was filed on 9.3.2021 but after lapse of around six months, no information has been given to the appellant so far. It is, thus apparent from the response of the respondent-PIO that there has been delay in providing the information. Appellant had also suffered financial loss in getting the information. There are systemic deficiencies in the manner of receiving and disposing of applications. The department still does not appear to be properly tuned to the performance of its obligations enshrined under the RTI Act.

3. I am, therefore, of the view that ends of justice would be met by awarding a sum of Rs. 10000/- (Rupees Ten Thousands only) by way of compensation to the Appellant. This amount shall be payable from the State Exchequer before the next date of hearing.

4. The respondent-Public Information Officer is also directed to file the reply/supply

12350 dated 11.1.2018 which is a part and parcel of the sought information attached with the enquiry report. He further states that he is being harassed by the respondent and requested to penalize the respondent and also requested for the compensation in this case.

3. None is present on behalf of the respondent. Although the appellant has sent the deficiencies to the respondent-Public Information Officer but none is present on behalf of the Public Information Officer o/o the Deputy Commissioner, District Ludhiana as well as the Public Information Officer o/o the Sub Registrar West, District Ludhiana.

4. The perusal of the file reveals that the appellant has sought the information vide his RTI application dated 26.6.2020. Since then few pages have been supplied to the appellant by the respondent that too uncertified. It is also a fact on record that the sought information relates to the appellant himself, who is around 79 years old. It is appropriate to mention that the officers committee comprising of District Revenue Officer, District Ludhiana, Addl. Deputy Commissioner, Jagraon and Addl. Deputy Commissioner, (Dev.) District Ludhiana submitted the enquiry report on 19.1.2018 in which they recommended the departmental action/enquiry against Naib Tehsildar Mullanpur Sh. Deepak Bhardwaj, Naib Tehsildar, Ludhiana West Sh. Harminder Singh Sidhu and Reader Sh. Vikas Kumar. It clearly reflects that the respondent authority is hiding the facts about the action being taken against the defaulters regarding the sought information by not supplying the action taken.

5. The perusal of the file shows that in this case, application for information was filed on 26.06.2020 but after lapse of more one year, neither any information has been given to the appellant so far nor the respondent-Public Information Officer is attending the hearing as he is absent in this case consecutively fifth time i.e. on 15.3.2021, 9.6.2021, 8.7.2021, 5.8.2021 and today i.e. 8.9.2021. It is, thus apparent from the response of the respondent-PIO that there has been delay in providing the information. Appellant had also suffered financial loss in getting the information. There are systemic deficiencies in the manner of receiving and disposing of applications. The department still does not appear to be properly tuned to the performance of its obligations enshrined under the RTI Act.

6. I am, therefore, of the view that ends of justice would be met by awarding a sum of Rs. 20,000/- (Rupees Twenty thousand only) by way of compensation to the Appellant. This

amount shall be payable from the State Exchequer by the respondent-Public Information Officer o/o Sub Registrar (west) Ludhiana before the next date of hearing.

7. The respondent-Public Information Officer is absent without intimation. Video Conference Facility was introduced for convenience of general public and for government officials. Viewing the absence of the respondent seriously, Sh. Jagsir Singh Sra, Sub Registrar (West) District Ludhiana is, thus, issued a show cause notice to explain in a self-attested affidavit as to why a penalty @ Rs.250/- per day of delay subject to a maximum of Rs.25000/- till the complete information is furnished, be not imposed under Section 20(1) of RTI Act, 2005 on him for causing wilful delay/denial of the information to the RTI applicant. In addition to the written reply, the PIO is also given an opportunity under Section 20(1) proviso thereto, for a personal hearing before the imposition of such penalty on the next date of hearing. He may take note that in case he does not file his written reply and does not avail himself of the opportunity of personal hearing on the next date, it will be presumed that he has nothing to say and the Commission will proceed ex-parte.

8. That the respondent-Public Information Officer o/o Sub Registrar (west) Ludhiana is also directed to remain present on the next date of hearing along with the original record.

9. That the appellant has sought the information from the Public Information Officer o/o the Deputy Commissioner, District Ludhiana and the said office transferred the RTI application of the appellant to the Sub Registrar (West), District Ludhiana. Therefore, directions are issued to the Public Information Officer (HRC Branch) o/o the Deputy Commissioner, District Ludhiana and Sub Registrar, Ludhiana (West), District Ludhiana to remain present on the next date of hearing along with the original record related to the sought information. Non compliance of this order will be viewed seriously.
