2. Complainant, Sh. T.R. Maini states that requisite information is still pending as no response has been received from the respondent PIO till date.
3. Respondent, PIO is continuously absent fifth time without any intimation to the commission for today's hearing, which shows no regard to the Notice of hearing and orders of the Commission as he was also absent on the previous hearings held on 15.05.2019, 24.07.2019, 05.02.2020 and 19.02.2020. Show Cause notice was issued to him dated 05.02.2020. Compensation amounting Rs. 3,000/- was awarded to the complainant vide order dated 05.02.2020 due to evasive and irresponsible behavior of the complainant and matter was adjourned for further hearing on 19.02.2020 but respondent PIO did not bother to represent this case or to comply with orders of the Commission.
4. Due to continues absence of the PIO despite of due notice(s) and directions under RTI Act, the concerned PIO O/o Commissioner, MC, Amritsar **has** not complied with the orders of the undersigned, therefore in exercise of powers vested in the Commission under section 18(3) of RTI Act read with relevant provisions of Civil Procedure Code, **I here by direct that Bailable Warrant be issued for appearance of concerned respondent PIO O/o Financial Commissioner Rural Development & Panchayat Dept. (General Section), Punjab, Chandigarh** to produce the record and give evidences pertaining to RTI queries dated 23.11.2018. **A copy of this order shall be endorsed to The Senior Superintendent of Police, S.A.S Nagar Mohali for executive of the bailable warrant.**
5. Respondent PIO, can present this case in Punjab State Information Commission, Sector -16 Chandigarh.

6. Matter is adjourned for further hearing on **28.04.2020 at 11:00 am through Video Conference at DC office Amritsar.**
