

**ORDER** 

The RTI application is dated 22.11.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter called FAA) on 26.2.2023 and second appeal was filed in the Commission on 1.3.2023 under Section 19 of the Right to Information Act, 2005 (hereinafter called RTI Act). Notice of hearing was issued to the parties for today.

2. The appellant has sought the following information as per his RTI application:-

Please provide me information if a class C cadre government school teacher in Fazilka is required to submit declarations regarding

1. Their movable and immovable assets(acquired or inherited) and gifts received exceeding Rs. 8000 from a relative.

2. Transactions whose value exceeds their one month gross salary.

3. Please also inform frequency(time of reporting) of reporting of such transactions by the employee mentioned in the service rules

- 3. The appellant submits that the directions may be issued to the respondent-Public Information Officer to supply the complete information. However, the representative of the respondents submits that a copy of the instructions/information as available on record has already been supplied to the appellant. He also submits that nothing more is available in the official record regarding the sought information which could be supplied to the appellant and requested to close the case. After hearing both the parties, the response of the respondent is accepted and the appellant is at liberty to file the RTI application afresh in case he intends to get any specific information.
- 4. Keeping in view the above, the Commission is of the view that no further action is required to be taken in this case. Hence, the case is disposed of and closed.

Your department had issued a letter vide memo number PA/SHE/2021/584-85) dated 29-10-2021 ( Copy attached) to the heads of different departments of Punjab for the appointment of District Language Officer. By which endorsement this letter was issued to the School Education, Provide me that endorsement letter and also by which email id this letter was issued to school education department, Provide me the screenshot of that email id as a sending proof. My complete information is related with the violation of article 16 of Indian constitution because I had not obtained this letter and the entire process of the recruitment of this District language officer had been completed through backdoor.

- 3. The appellant submits that the directions may be issued to the respondent-Public Information Officer to supply the complete information. However, the respondent already sent a copy of an email as has been sought by the appellant, which is taken on record. After hearing the contents of the said email the appellant submits that he is satisfied with the same and requested for a hard copy of the same which is **being sent** to the appellant along with this order. He also submits that he has no objection, if the present case is closed.
- 4. In view of the submissions made by the appellant, the Commission is of the view that no further action is required to be taken in this case. Hence, the case is disposed of and closed.
