This case was last heard on 17.07.2019 and PIO/Respondent was directed to supply the requisite samples to the Appellant after collecting the assessed fees from the Appellant as discussed in the previous order dated 17.07.2019.

In today's hearing, the APIO, Sh. Kulwinder Singh states that they have written a registered postal letter to the Appellant for visiting their office on 22.08.2019 for collecting the requisite samples but the Appellant didn't visit their office. In relating to this, he further submits a letter dated 1682 dated 09.09.2019 along with a copy of postal receipt through which the letter has been sent to the Appellant.

On that postal receipt the date is 21.08.2018 which means the letter had never been posted by the Respondent/PIO till date and they are trying to produce the fraudulent documents in the Court, which is not acceptable.

The PIO, Sh. Ranbir Singh is directed to appear personally on the next date of hearing for clearing the facts of this case and he is further directed to go through the

previous order dated 17.07.2019 and compliance the same for giving the samples to the Appellant by setting out a date with the Appellant through telephone or through registered post.

**In view of the above, a penalty of Rs.2500/- (Rupees Two thousand Five hundred only) is imposed on the concerned PIO, O/o Executive Officer, Municipal Council, Amlah Road, Khanna, District Ludhiana. The amount of penalty i.e. Rs.2500/- should be deducted from the salary of the PIO and be deposited in the Govt. Treasury under the head "0070-Other Administrative Services-60-Other Services-800-Other Receipts-86-Fees under the Right to Information Act".**

**Due to evasive attitude of the representative of the Respondent/PIO, O/o The Executive Officer, MC, Khanna, Distt. Ludhiana and wasting the valuable time of the Court as well as of the Appellant, a compensation of Rs. 2000/- (Rupees Two Thousand Only) is awarded to the Appellant, Sh. Ramandeep Singh for the above mentioned case. The compensation shall be paid by Public Authority concerned ( PIO O/o The Executive Officer, MC, Khanna, Distt. Ludhiana) by way of crossed Cheque/Demand Draft in the name of Ramandeep Singh. The crossed Cheque/Demand Draft shall be made from the bank account of public authority concerned and not from the individual official.**

PIO/Respondent is also directed to come in person and submit the proof of having deposited the penalty to Government Treasury as well as the compensation amount in favour of the Appellant on the next date of hearing. PIO/Respondent is further directed to supply the complete information before the next date of hearing. Copy of this order be sent to him through registered post for his ready reference.

The case is adjourned to next date of hearing fixed for **26.11.2019 at 11.00 AM.**
