ORDER:

The complainant through RTI application dated 15.02.2019 has sought information regarding Copy of order of FCR Punjab dated 26.04.2011 on the basis of which ownership of land in village Kuttianwali was transferred vide mutation No.4325 alongwith the policy to allot evacuee property to disabled persons and other information concerning the office of Tehsildar Lambi. The appellant was not satisfied with the reply of the PIO dated 24.04.2019 whereby the PIO was asked to get the information from their field staff, after which the complainant filed complaint in the Commission on 13.05.2019.

ORDER:

The appellant through RTI application dated 30.01.2019 has sought information regarding enlistment of contractor M/s Goel Construction/Goyal Construction vide letter No.1844 dated 1-3-2017 and other information concerning the office of EO-MC Amlah.
