3. After hearing both the parties and going through the record available on the case file, it has come to light that the information sought by the Appellant is third party information and also personnel information as contemplated under Section 8(1)(j) of RTI Act. As per case decided on 03.10.2012 by the Hon'ble Supreme Court of India in SLP (civil no. 27734 of 2012) titled "Girish Ram Chandra Deshpande vs. CIC, New Delhi and others", which relates to personnel information the disclosure of which has no relationship to any public activity or interest, the PIO is not bound to give such information. In the instant appeal case also there is no public interest involved in supply of information demanded by the appellant. As such the complainant in the Commission is **dismissed**. 3. After hearing both the parties and going through the record available on the case file it is observed that information-seeker failed to provide number and date of complaint. So, the information could not be supplied. The appellant is advised to give number and date of his complaint and get the information from the respondent after following the procedure afresh under the provisions of the RTI Act, 2005. With these observations, the present case is **disposed of** and **closed**. Copies of the order be sent to the parties.

He hands over a Bank Draft bearing No.781499 dated 8.3.2019 for Rs.3000/- issued by Oriental Bank of Commerce, Ludhiana during the hearing to the appellant. He further states that complete information has been supplied to the appellant on 05.07.2017 by the PIO and again on 27.07.2017 by the First Appellant Authority.
