The PIO has provided the appellant with a reply vide Letter No. 94 dated 6.6.2024 along with a copy of Roadcut bill, which was available in the file pertaining to the plot cited in the RTI application along with a copy of one water supply bill that was available in the said file.

3. Notably, this RTI application was submitted to the PIO O/o BDA, Bathinda on 20.02.2023 and information was provided to the appellant online on 06.06.2024, after the lapse of more than one and a half years. Consequently, the appellant was forced to face much harassment for no fault of her own. Accordingly, the Commission deems it appropriate to award a **compensation of Rs. 10,000.00 (Rs. Ten Thousand)** to the appellant, Smt. Amanjot Kaur, for the harassment and detriment caused to her. This is to be paid vide a crossed cheque / demand draft, by the Public Authority, in this instance, the office of Bathinda Development Authority, Bathinda, within 15 days of receiving this Order. Proof of payment is to be submitted to this Commission.

4. With the aforesaid directions, the appeal case is **Disposed of.**

as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **26.6.2023** and Second Appeal was filed in the Commission on **10.8.2023** under Section 19 of the Right to Information Act, 2005. This case was last heard on **27.05.2024**.

2. The appellant was exempted from today's Hearing. At the Hearing on 27.03.2024, the Commission had impleaded the Commissioner Municipal Corporation Patiala, Sh. Aditiya Dachalwal, IAS, as deemed PIO in this appeal case and directed him to institute an inquiry to fix the responsibility for the initial delay in addressing this RTI application. The Commissioner, M.C, Patiala has submitted his report vide Letter No. 941/BLD Dated 07.06.2024 stating that Sh. Naresh Kumar, MTP was the designated PIO at the time of filling this RTI application on 16.05.2023.

3. The Sh. Naresh Kumar, PIO-cum-MTP, who was incumbent at the time of filling the RTI application, he has not performed his duty as mandated by the RTI regime. Such conduct deserves to be appropriately condemned.

4. Keeping all the facts of the case in mind, this is a fit case to invoke Section 20 of RTI Act and impose a penalty on the respondent PIO Section 20(1), which reads as under:

“Where the Central Information Commission or the State Information Commission, as the case may be, at the time of deciding any complaint or appeal is of the opinion that the Central Public Information Officer or the State Public Information Officer, as the case may be, has, without any reasonable cause, refused to receive an application for information or has not furnished information within the time specified under sub Section (1) of Section 7 or malafidely denied the request for information or knowingly given incorrect, incomplete or misleading information or destroyed information which was the subject of the request or obstructed in any manner in furnishing the information, it shall impose a penalty of 250/- Rupees each day till application is received or information is furnished, so however, the total amount of such penalty shall not exceed Twenty Five Thousand Rupees;

Provided that the Central Public Officer or the State Public Information Officer, as the case may be, shall be given a reasonable opportunity of being heard before any penalty is imposed on him;

Provided further that the burden of proving that he acted reasonably and diligently shall be on the Central Information Officer, as the case may be.”

5. The onus and responsibility lie on the PIO to ensure the transmission of the complete information to the appellant. The PIO Sh. Naresh Kumar, MTP, is hereby held guilty for not providing the information on time as prescribed under Section 7, which is within 30 days of the receipt of the request and for repeated and willful defiance of the Punjab State Information Commission's orders. A penalty of **Rupees Ten Thousand (Rs. 10,000.00) is hereby imposed upon the PIO Sh. Naresh Kumar, MTP, currently posted at Pathankot, which be deducted from his salary and deposited in the Punjab Government Treasury under head “0070-Other Administrative Services-60-other Services-800-Other Receipts-86-Fees Under the Right to Information Act.”** The PIO O/o Commissioner, MC, Patiala, is directed to duly inform the Commission of the compliance of the orders by producing a copy of the challan at the next hearing of this appeal case.

6. I have also looked into all the facts and circumstances of the case. In my view this is a fit case, where award of compensation under Section 19 (8) (b) is also called for. I have no doubt in my mind that this state of affairs has also come about on account of the absence of adequate machinery for handling the RTI work in the o/o Commissioner, M.C, Patiala, is thus, responsible for the inadequate handling of the RTI requests and in the instant case as well. I, therefore, order that **compensation of Rs. 10,000.00 (Rs. Ten thousand only)** be paid to the appellant Sh. Sunny Gurabba for the detriments suffered by him. This amount shall be payable from the funds of the o/o Commissioner, M.C, Patiala by way of Demand Draft/Check to the appellant within one month.

7. The respondent PIO is further directed to provide the point wise reply to the RTI application with duly attested copies of the information, as available in the records. This must be done within ten days from the receipt of this Order.
