ORDERS

The RTI application is dated 10.07.2020 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) and second appeal was filed in the Commission on 19.10.2020 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).

2. Notice of hearing was issued to the parties for 12.01.2021 through CISCO-Webex(VideoConferencing application.)

3. The Respondent states that they are not covered under the RTI Act.They have also filed their reply vide Commission diary no.19015 dated 21.12.2020 stating as under:-

“ With due respect, it is humbly submitted that the aforesaid appeal filed against us is not legally sustainable as per the provisions of Right to Information Act, 2005. Sir, Gaushala Committee (Regd.) Lehragaga, District Sangrur is a non-public authority as it is a NGO being run by a group of private persons for welfare of Cows. This Committee is being run with the funds collected from local public and it has no grant whatsoever form any govt. agency not it is being financed by any govt. agency. RTI Act is applicable on the public authority which covers NGOs substantially financed directly or indirectly by funds provided by appropriate govt. and this provision is not applicable to our committee at all.”

ORDER

The RTI application is dated 18.07.2020 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) and second appeal was filed in the Commission on 20.10.2020 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).

2. Notice of hearing was issued to the parties for 12.01.2021 through CISCO-Webex(VideoConferencing application.)
3. The Appellant is not present today. However, he has sent an e-mail authorizing Sh.VarunBansalto appear on his behalf.
4. The Respondent Sh. Rajnish Garg states that the information, as available, in their official record has been provided to the Appellant. The Respondent has also filed his reply, which as under:-

Sr. No.	Query	Reply
01	Kindly provide me details about the Marks obtained by me in recruitment text for the post of clerk under Dept. of Medical Education and Research, Govt. of Punjab.	Obtained 72 marks out of 100 under General Category for the post of clerk, written test held on 06.07.2020.
02	Kindly provide me details about the Marks obtained by all other qualified candidates in above said exam.	University was just nodal agency to conduct the recruitment exam on behalf of the Govt. of Punjab. The final appointing authority is Govt. of Punjab. Further, it is submitted that complete record for the post of clerk was forwarded to Dept. of Medical Education and Research, Govt. of Punjab and The Principal, Dr.B.R. Ambedkar State Institute of Medical Sciences, Mohali vide letter no. 03-BFUHS/J.A/Admn/2020/SPL-1 Dated 25.09.2020 and No. 15 BFUHS (recruitment)/21225 Dated 19.11.2020. (Copies of same is enclosed herewith Pages2) it is added that the result for the post of clerk has not been declared by the University nor it has been uploaded on the university website.

5. I have gone through the reply filed by the respondent and have agreed with it.

6. The appellant may also take note that each of these authorities has also separate PIOs. Under-section 6(1)(a) a person seeking information has to apply to the concerned public authority. It is not the job of one PIO to collect and therefore collate all the information from different PIOs of different Public Authorities and thereafter supply the same to the appellant. The appellant may however approach the concerned PIOs with fresh application/s if he wants the information. I find no merit in the appeal and the same is dismissed. Copy of the orders be sent to the parties.
