Respondent/PIO assured that the requisite information relating to copies of Cash Book from August, 2013 to 15.11.2017 along with attested copies of MB will be supplied to the Appellant by registered post by or before next date of hearing. The Respondent/PIO is directed to appear in person or through any of his representative, on the next date of hearing. The Appellant, Sh. Janak Singh, on receipt of requisite information, is also advised to go through the information and point out the deficiencies, if any, in written to the Respondent/PIO with a copy to the Commission.

Both the parties to come present on next date of hearing.

The case is adjourned to **09.01.2019 at 11 A.M.**
