3. Respondent, Sh. Major Singh states that information of one (01) school is pending in connection with point no. 1 of the RTI application and information in connection with point no. 2 has already been supplied to the appellant.
4. After hearing both the parties and examining the case file, respondent PIO is directed to supply the pending information of 01 school in connection with point no. 1 of the RTI application along with directions to file an affidavit in connection with point no. 2 of the RTI application to put before the Commission on the next date of hearing positively.
5. Matter is adjourned for further hearing on **03.12.2018 at 11:30 AM**.
