ORDER:

The RTI Application is dated 05.06.2018.. The date of appeal is 10.09.2018 and the date of 2nd Appeal filed in the Commission is 17.12.2018.

Shri Ankush Chaudhary, Advocate comes present on behalf of the Appellant Sh. Sham Sunder Kapoor and states that no information has been received by the Appellant. Shri Amit, Data Entry Operator appears and produces authority letter. He also produces letter No.3396 dated 11.03.2019 vide which it is stated that the Appellant was intimated that he has sought entire record of off-lien and on-line issued licenses of the license holders i.e. educational qualification, Aadhar card etc. from 01.01.2018 to 05.04.2018 which is third information and cannot be disclosed. It is further stated that the appellant can get this information only after seeking consent of the license holders. He also submits a copy to the Court which is taken on record.

The Appellant states that he does not know Punjabi language and as such, wants to go through the contents of letter dated 11.03.2019. He is advised to go through this letter and point out deficiencies to the PIO/Respondent with a copy to the Commission. PIO/Respondent is also directed to come personally on the next date of hearing.

The case is adjourned to next date of hearing which is fixed for **06.05.2019 at 11.00 AM.**
