1. The RTI application is dated 16.07.2020 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 21.08.2020 and the second appeal was filed in the Commission on 10.11.2020 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. The notice for the hearing was issued to the parties for 13.01.2021 through V.C. in D.C. Office, Amritsar. Accordingly, the appeal case has been heard today through V.C.
3. Shri Anish Kumar, appellant has come present to attend the hearing through V.C. He states that incomplete information has been received by him. He had sought information on whether the estimates for the repair of 66 KV cables have been prepared on technical ground or estimate ground, the reasons thereof also be assigned which have not been shared.
4. Shri Naresh Sharma, Addl. S.E. PSPCL Amritsar comes present to attend the hearing through V.C. and states that the information as available in the official records has been supplied to the appellant vide letter dated 24.08.2020 of Addl. S.E. P&M Division-2, Amritsar, vide letter dated 25.08.2020 & 26.08.2020 of Sr. XEN, P&M Division, Gurdaspur and Tarn Taran respectively and has again been sent vide letter dated 27.08.2020 by the office of Dy. Chief Engineer, P&M Circle, PSPCL, Amritsar.

5. Post deliberations with the appellant and the PIO, the Bench makes it clear to the appellant that as per version of the PIO, whatever information was available in their official records, has been supplied to the appellant. The reasons asked for by the appellant regarding as to why estimates have been prepared in a particular ground manner, are not available in the official documents and as such, does not constitute part of the information and thus, cannot be made available. The Bench further directs the PIO to file an affidavit within a week duly signed by the PIO and attested by the Notary Public to the effect that the information as available in the official records in AC No.3564 of 2020 has been supplied to the appellant. It be further stated that nothing has been concealed therein and the statement made is true and correct. Original copy of affidavit be sent to the appellant and photocopy of the same be sent to the Commission for record.

6. With the aforesaid directions, **the appeal case is disposed off and closed.** The copies of the order be sent to the concerned parties.
