ORDER

This order may be read with reference to the previous order dated 4.11.2020.

2. The appellant has sought the following information:-

3. The appellant states that he has received the complete information through whatsapp and he is satisfied with the information provided but requested for the hard copy of the same.

4. The representative of the respondents assured that the hard copy of the information will also be sent to the appellant through speed/registered post.

5. The appellant is satisfied with the information so supplied by the respondents and the representative of the respondents assured that the same will be sent to the appellant through registered post. Accordingly, the Commission observes that no cause of action is left in this case. Hence, the case is disposed of and closed.
