ORDER

The RTI application is dated 03.08.2018 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter called FAA) on 06.09.2018 and second appeal was filed in the Commission on 18.10.2018 under Section 19 of the Right to Information Act, 2005 (hereinafter called RTI Act).

2. Notice of hearing was issued to the parties for today.

3. The appellant is absent but she has sent an e-mail stating that no information has been supplied to her by the respondents.

4. The respondents have sent their reply to the appellant vide their letter dated 30.07.2018 enclosing the inquiry report of the Sub Divisional Magistrate, Jagraon.

The necessary contents of the inquiry report are reproduced below:-

ਦੂਜੀ ਧਿਰ ਪੇਸ਼ ਹੋਈ ਤੇ ਕਿਹਾ ਕਿ ਉਸ ਵਲੋਂ ਦਰਖਾਸਤਕਰਤਾ ਨੂੰ ਤੰਗ ਪ੍ਰੇਸ਼ਾਨ ਨਹੀਂ ਕੀਤਾ ਜਾ ਰਿਹਾ ਤੇ ਦਰਖਾਸਤ ਝੂਠੀ ਤੇ ਬੇ-ਬੁਨਿਆਦ ਹੈ। ਇਸ ਲਈ ਖਾਰਜ ਕੀਤੀ ਜਾਵੇ।

ਦਰਖਾਸਤ ਕਰਤਾ ਤਾਰਾ ਦੇਵੀ ਨੂੰ ਪੁਛਿਆ ਗਿਆ ਕਿ ਉਸ ਨੇ ਖਰਚਾ ਲੈਣਾ ਜਾਂ ਮਕਾਨ ਖਾਲੀ ਕਰਵਾਉਣਾ ਹੈ ਤਾਂ ਇਸ ਤੇ ਤਾਰਾ ਦੇਵੀ ਨੇ ਸਿਰਫ ਮਕਾਨ ਖਾਲੀ ਕਰਵਾਉਣ ਦੀ ਮੰਗ ਰੱਖੀ। ਇਸ ਉਪਰੰਤ ਉਸ ਨੂੰ ਦਸਿਆ ਗਿਆ ਕਿ ਜੇ ਉਸ ਨੇ ਮਕਾਨ ਖਾਲੀ ਕਰਵਾਉਣਾ ਹੈ ਤਾਂ ਉਹ ਆਪਣੀ ਦਰਖਾਸਤ ਜਿਲ੍ਹਾ ਕੁਲੈਕਟਰ ਸਾਹਿਬ ਦੇ ਪੇਸ਼ ਕਰੇ। ਜਸ ਤੇ ਤਾਰਾ ਦੇਵੀ ਦਰਖਾਸਤਕਰਤਾ ਨੇ ਸਹਿਮਤੀ ਜਤਾਈ। ਕਿਉਂਕਿ ਇਸ ਦਰਖਾਸਤ ਦਾ ਸੰਬੰਧ ਖਰਚੇ ਨਾਲ ਨਹੀਂ ਹੈ। ਇਸ ਲਈ ਦਰਖਾਸਤ ਖਾਰਜ ਕੀਤੀ ਜਾਂਦੀ ਹੈ। ਮਿਸਲ ਬਾਅਦ ਤਰਤੀਬ ਵ ਤਕਮੀਲ ਦਾਖਲ ਰਿਕਾਰਡ ਰੂਮ ਕਰਵਾਈ ਜਾਵੇ।”

5. After going through the record available on the case file including the application for seeking information under RTI Act and reply given by the respondents, it is revealed that complete information has been supplied including inquiry report. Jurisdiction of this Commission is limited to help the appellant to get the information as available in the record of the respondents. The appellant is advised to file the case before the District Collector for eviction of the house as advised by the First Appellate Authority. With these observations, the present case is **disposed of** and **closed**. Copies of the order be sent to the parties.
