Viewing the absence of Shri Dilbagh Chand, Panchayat Secretary-cum-PIO, the PIO is, thus, issued a show cause notice to explain in a self-attested affidavit as to why a penalty @ Rs.250/- per day of delay subject to a maximum of Rs.25000/- till the complete information is furnished, be not imposed under Section 20(1) of RTI Act, 2005 on his for causing willful delay/denial of the information to the RTI applicant and why the compensation be not awarded to the information-seeker under Section 19(8)(b)of the Act for the detriment suffered by him.

4. In addition to the written reply, the PIO is also given an opportunity under Section 20(1) proviso thereto, for a personal hearing before the imposition of such penalty on the next date of hearing. He may take note that in case he does not file his written reply and does not avail himself of the opportunity of personal hearing on the date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceedings against him ex parte.

4. The PIO is directed to supply the information before the next date of hearing which is fixed for hearing on 15.01.2020 at 3.00 P.M. through Video Conference Facility available in the office of the Deputy Commissioner, Ferozepur.
