ORDER

This order may be read with reference to the previous order Dated 16.8.2021.

2. The respondent-Public Information Officer states that lien of Punjab Small Industries & Export Corporation (PSIEC) has been marked in the revenue record as the said corporation has informed to mark the lien to the Revenue Department vide letter No. 778-780 dated 20.11.2017. He further states that in spite of the best effort the said letter could not be traced. Regarding the notification to acquire the said land the respondent-Public Information Officer also states in this regard the copy of said acquisition can be obtained from the PSIEC. However, the appellant states that he is seeking the copy of the said letter and the notification of the Government of Punjab/PSIEC and the respondent may be directed to supply the same.

3. As per Section 6(3) of the RTI Act, 2005 the public authority has to transfer the RTI application to the concerned public authority in case the sought information relates to the

other public authority. But in the titled case no such procedure has been adopted by the respondent authority. Therefore, the directions are issued to the respondent-Public Information Officer to make sure that in future, Section 6(3) of the RTI application be complied with as mentioned herein. He is also directed to transfer the RTI application of the appellant to the Public Information Officer o/o the PSIEC under Section 6(3) of the RTI Act, 2005. Also the Public Information Officer o/o the PSIEC is impleaded as necessary party in this case to file the reply/supply the information. A copy of the RTI application along with the submissions made by the Tehsildar East, District Ludhiana is being **sent** along with this order.

4. Also the Public Information Officer-cum-Tehsildar East, District Ludhiana is directed to make an effort to trace the said record else file a specific undertaking in this regard before the next date of hearing. Also one opportunity is granted to the respondent-Public Information Officer-cum-Tehsildar East, District Ludhiana Sh. Navdeep Bhogal to file the reply regarding show cause notice issued to him failing which ex-parte decision will be taken on the next date of hearing.
