#### ORDER:

- 1.The RTI application is dated **28.08.2022** vide which the appellant has sought information regarding:
  - Certified copies of following documents: (a) Balance sheets of C-PYTE of Year 2018-19, 2019-20,
    - (a) Balance sheets of C-PYTE of Year 2018-13, 2013-20 2020-21 and 2021-22.
    - (b) Income and Expenditure statements of year 2018-19, 2019-20, 2020-21 and 2021-22.
    - (c) Receipt and Payment statements of year 2018-19, 2019-20, 2020-21 and 2021-22.
  - Certified copies of Audit observation and final objections raised by Auditor General in the Audit of C-PYTE from 2018 to 2022.
  - Certified copy of details of total grant allotted for the year 2021-22 and the balance (unexpended) at the end of financial year 2021-22.

as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on **07.10.2022** and the second appeal was filed in the Commission on **02.01.2023** under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act). This case was last heard on **25.04.2023**.

- 2. An Order in this appeal case was reserved on 25.04.2023. As per a written submission made by the appellant, the information sought by him was denied as 'Third Party Information' and 'Personal Information' under Section 8(i)(j) of the RTI Act, 2005.
- 3. The Commission has examined the RTI application and is of the considered view that the information sought herein does not qualify for exemption either under Section 11 (Thirty Party Information or under Section 8(i)(j) (Personal Information). Accordingly, the respondent PIO is hereby directed to provide the information sought by the appellant, by way of duly certified copies. This must be done within ten days from the receipt of this Order.
