After hearing the representative of the appellant and going through the record available on the case file, it is observed that the appellant failed to send deficiencies to the respondents, in the information supplied to him, with a copy to the Commission. He is again advised to send deficiencies in the information to the respondents within three days with a copy to the Commission failing which exparte decision will be taken. Absence of Shri Paramjit Singh, Panchayat Secretary, is viewed seriously. He is directed to remove deficiencies on its receipt from the appellant and appear before the Commission on the next date of hearing failing which punitive action will be initiated.
- 4. To come up on 27.1.2020 at 3.00 P.M. to be heard through Video Conference Facility available in the office of Deputy Commissioner, Jalandhar.
