

The respondent PIO has submitted a detailed reply to this Commission's Notice of Hearing, which was received in this Commission vide Diary No. 20429 Dated 8.9.2022, wherein he has explained that the significant part of the RTI application is personal information and has cited two separate judgments of the Hon'ble Supreme Court of India in support of his contention. The Commission is of the view that apart from the information being personal in nature, it also qualifies for exemption under Section 7(9) of the RTI Act 2005, because the sheer volume of information requested. This would require huge time and effort to collect, and would, invariably, result in a disproportionate diversion of public resources. The respondent PIO's decision is upheld.
- 6. This Appeal Case is accordingly **Disposed of**.




