**ORDER**

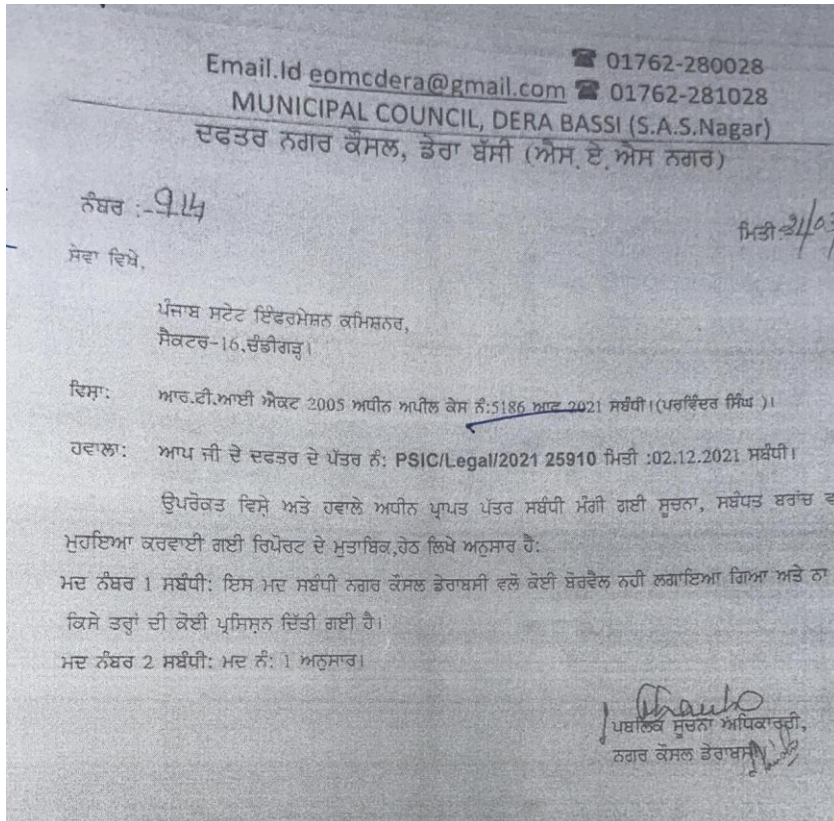
