ORDER

1. This order may be read with reference to the previous order dated 10.08.2020 vide which respondent PIO, Sh. Pardeep Jaiswal intimated the Commission due to Covid19, office was closed and requested for an adjournment. Matter was adjourned for further hearing on 16.09.2020 i.e. today.

2. In today's hearing, appellant, Advocate, Ravinder Singh states that pending information has not been supplied to him till date.

3. Neither the respondent PIO is present for today's hearing nor did he file reply in this regard. He was also absent on the previous hearings held on 16.12.2019, 29.01.2020, 03.03.2020, 13.07.2020 and 10.08.2020.

4. After hearing the appellant and examining the case file, respondent, Sh. Jagjeet Singh (JE) appeared on hearing held on 29.01.2020 stated that requisite information from year 2017 has already been supplied to the appellant and record from 2014 to 2016 is in the custody of the earlier concerned official.

A last and final opportunity was given to him represent this case along with directions to comply with the previous orders of the Commission, failing to which punitive action will be initiated against him.

Show-Cause notice was issued to the respondent PIO vide order dated 03.03.2020. A copy of previous order dated 03.03.2020 was sent to the concerned official, through registered post, but he didn't pay any attention on the directions by the Commission, which represents his irresponsible behavior for his duties as a public servant.

5. In view of the defying attitude of the respondent PIO neither attending the court nor submitting any explanation for the delay in supplying the information within the time schedule as prescribed under the RTI Act 2005, the court comes to a logical conclusion that it is a fit case for the imposition of penalty amounting to Rs. 25,000/- (Rupees Twenty Five thousand only) on the PIO. Therefore, taking a lenient view, **I impose a penalty of Rs. 5,000/- (Rs. Five Thousand Only) on the concerned respondent PIO, Sh. Pardeep Jaiswal**, Office of Improvement Trust, Ranjit Avenue, Amritsar. **The Drawing and Disbursing Officer of the office of the Executive Officer, Improvement Trust, Amritsar** is directed to deduct the amount of penalty of Rs. 5,000/- from the salary of the concerned respondent PIO and deposited in the State Treasury in the following Head of Account and to report its compliance to the Commission:-

“0070-Other Administrative Services

60 other Services

800-Other Receipts

86-Fee under the RTI Act, 2005”

6. Due to evasive attitude of the respondent PIO concerned, the applicant has suffered lot of detriments for not getting the complete requisite information, I am of the view, that compensation be awarded to the appellant, Advocate, Ravinder Singh.

Hence **I award a compensation of Rs. 3,000/- (Three Thousand)** to the appellant. The compensation amount must be paid by the respondent PIO concerned through cheque or demand draft in favour of Ravinder Singh from the account of Public Authority concerned and not from the individual's account.

Respondent PIO is also directed to produce a copy of the cheque or demand draft on the next date of hearing.

7. **A copy of this order be sent to respondent PIO, Sh. Pardeep Jaiswal by name through registered post for his ready reference.**

8. **A copy of this order be sent to the disbursing officer, who is Executive Officer, Improvement Trust, Amritsar by name through registered post for the compliance of this order and make sure the concerned official attend the hearing**
