1. This order may be read with reference to the order dated 28.07.2020 passed by this Bench on the previous date of hearing.
2. The case has been heard today through Cisco Webex. The appellant Shri Shakti Bhushan attends the hearing through CISCO Webex/ on mobile phone. He states that no information has been provided to him as yet in the instant appeal case.
3. The PIO O/o Vehicle Registering Authority, SDM Nabha, District Patiala has not attended the hearing through Cisco Webex.
4. On the asking of the Bench, the appellant states that he had visited the office of SDM Nabha to inspect the official records and to identify the information as required vide his RTI application. However, he was not entertained at all and was told that at first, they will ascertain as to which of the other offices have given him such information, only then they will think of providing him the information. It amounts to non-compliance of the directions given by the Bench on the previous hearing.
5. The Bench, on perusal of case file, also finds that an affidavit has been received from the PIO stating that one tractor was registered in the name of one Rupinder Singh who, vide his letter dated 01.09.2020, has refused to give consent to share information regarding the registration of his tractor.

5. The Bench observes that the appellant has sought copies of the bills on the basis of which registration of Swaraj Tractors was done by the Vehicle Registration Authority, Nabha. The Bench is of the opinion that this is the official record and is in the public domain, being available on the relevant portal of the Vehicle Registration Authority. As such, the information asked for by the appellant cannot be termed as personal and third party information. The PIO is directed to make available to the appellant the information asked for by him.

6. PIO is also directed to file another affidavit, before next hearing, duly signed by the PIO and attested by the Notary Public to the effect that information in AC No.1086 of 2020, as available in the official records, has been provided to the Appellant and nothing has been concealed therein. The information supplied is correct and authentic. The original copy of affidavit be sent to the appellant and a photocopy thereof be sent to the Commission for record.

5. The Bench observes that the appellant has sought copies of the bills on the basis of which registration of Swaraj Tractors was done by the Vehicle Registration Authority, Rajpura. The Bench is of the opinion that the information sought is not third party as it is available on the relevant portal and the information also is being obtained from Swaraj Tractors (commercial venture) and not from individuals. As such, the contention of the PIO that the information asked for by the appellant cannot be supplied stands over ruled.

6. PIO is also directed to file affidavit, before the next hearing, duly signed by the PIO and attested by the Notary Public to the effect that information in AC No.1087 of 2020, as available in the official records, has been provided to the Appellant and nothing has been concealed therein. The information supplied is correct and authentic. The original copy of affidavit be sent to the appellant and a photocopy thereof be sent to the Commission for record.

The PIO O/o Secretary, Regional Transport Authority, Gurdaspur is issued show cause notice to explain his absence and to explain as to why action should not be taken against him and also as to why penalty should not be imposed in the instant case for non-compliance of the directions given by the Bench on the previous hearing. He is also directed to file a written reply to the show cause notice as to why the appellant should not be compensated for the mental harassment suffered by him in getting the information.

6. In addition to the written reply, PIO is hereby given an opportunity u/s 20(1) proviso thereto for a personal hearing before the imposition of such a penalty, on the next date of hearing. He may take note that in case he does not file the written reply and does not avail himself of the opportunity of personal hearing on the next date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceeding against him ex-parte.

7. The PIO is also directed to provide the complete information to the appellant as per is RTI application as also to file an affidavit as directed on the previous hearing before the next hearing. The original copy of the affidavit be sent to the appellant and photocopy thereof be sent to the Commission for record.
