4. Post deliberations, the appellant is advised to visit the office of PIO to inspect the official records and identify the information. The PIO will allow him access to the relevant official records and will provide the information which may be identified by the appellant.
5. The PIO is also directed to file reply to the show cause notice before the next hearing and also to file an affidavit as per directions given on the previous date of hearing.

1. This order may be read with reference to the order dated 15.09.2020 passed by this Bench on the previous date of hearing.
2. The case has been heard today through V.C. in D.C. Office, Gurdaspur. The appellant Shri Surinder Kumar comes present and states that some information has been provided to him and that deficiencies pointed out by him to the PIO have also not been addressed.
3. Neither the PIO has come present to attend the hearing through V.C. nor has deputed any of his representative to attend the hearing on his behalf. However, a letter dated 17.09.2020 has been received from the PIO stating that an appeal case No.1222/2020 has already been disposed off by this Bench vide order dated 04.08.2020 and the subject matter of said case is the same as that of the instant appeal case No.1502 of 2020 and has requested to dispose off the same.
4. The Bench, as per the version of the PIO, peruses the relevant case file and observes that the RTI applications of the appellant in both the cases are the same, but finds from the perusal of order dated 04.08.2020 passed in AC No.1222/2020 that the said appeal case was disposed off on the withdrawal of that appeal case by the appellant himself. On enquiring from the appellant, he states that being the same subject, he had withdrawn AC No.1222/2020 and now he wants to pursue the instant appeal case.

5. The Bench further observes that the PIO has not complied with the directions of the Bench given on the previous hearing and has also not come present to attend the hearing. The PIO O/o Executive Officer, Municipal Council, Fatehgarh Churian, District Gurdaspur is issued show cause notice to explain his absence and to explain as to why action should not be taken against him for not complying with the direction of the Bench and also as to why penalty should not be imposed in the instant case for not supplying the information to the appellant. He is also directed to file a written reply to the show cause notice as to why the appellant should not be compensated for the mental harassment suffered by him in getting the information.

6. In addition to the written reply, PIO is hereby given an opportunity u/s 20(1) proviso thereto for a personal hearing before the imposition of such a penalty, on the next date of hearing. He may take note that in case he does not file the written reply and does not avail himself of the opportunity of personal hearing on the next date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceeding against him ex-parte.

7. The PIO is directed to supply the entire information to the appellant after addressing the deficiencies pointed out by the appellant before next date of hearing and also to comply with the direction given on the previous hearing as also to ensure to attend the next hearing in person through V.C.

8. With the aforesaid directions, the matter is adjourned. **To come up for hearing on 02.02.2021 at 11.30 AM through V.C. in D.C. Office, Gurdaspur.** Copies of order be given to the concerned parties.

1. The RTI application is dated 12.04.2019 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 10.07.2020 and the second appeal was filed in the Commission on 08.09.2020 under Section 19 of the 2Right to Information Act, 2005 (hereinafter RTI Act).
2. Notice of hearing was issued to the parties for 16.11.2020 by the Commission through Video Conferencing facility in the office of D.C. Gurdaspur. Shri Khushal Chand Vohra, appellant comes present to attend the hearing through V.C. and states that he has sought videography CCTV footage of the camera installed in Police Station, Dera Baba Nanak from 27.03.2019 to 07.04.2019 which has not been made available to him by the PIO.
3. SI Mohinder Pal, Addl.SHO/PIO, Police Station, Dera Baba Nanak, District Gurdaspur comes present and states that reply has been given vide letter dated 27.10.2020 to the effect that the Police Station, Dera Baba Nanak, falls in the border area and from security point of view, meetings are often held with the Army, B.S.F. and security related agencies, due to which the CCTV footage of PS Dera Baba Nanak cannot be supplied.

4. On enquiring from the appellant and his son accompanying him, states that an accused was got arrested at their instance but on their further enquiry, it was found that the said accused was not found arrested in the official records and the officials of the Police Station denied to have arrested any accused at their instance. It is implied that the said accused had been set free by the Police Officials on their own without taking any action against him. He further states that this is their main grievance and that is why, the said CCTV footage is required by them.

5. On listening to the version of the appellant, the Bench is convinced and observes that the information asked for by the appellant deserves to be provided to him as it points to wrong doing and corruption by the Police Station under question. Therefore, the Bench over-rules the contention raised by the SHO, Police Station, Dera Baba Nanak on the plea of security reasons and directs the PIO O/o SHO Police Station, Dera Baba Nanak, District Gurdaspur to provide the appellant the CCTV camera footage for the period sought, before the next hearing.

6. With the aforesaid directions, the matter is adjourned. **To come up for hearing on 02.02.2021 at 11.30 AM through V.C. in D.C. Office, Gurdaspur.** Copies of order be given to the concerned parties.
