and on perusing the Pass, he was told that the pass relates to Punjab Roadways which is not valid for PRTC buses. But he insisted on to travel by that bus and also did not behave properly in spite of the fact that the bus was not going to stop at Jagraon and was bound for Moga only. The bus was taken by them to Moga Police Station and a complaint was made to the Police but copy of the same is not with them and same is only with the Police Station, Moga. He also clarifies that the bus in question was a non-stop bus and the bus to ply with several stoppages was to leave just two minutes after the bus boarded by son of the appellant.

5. On hearing the version of the APIO O/o GM PRTC Faridkot, the Bench observes that adequate information stands supplied to the appellant. Issue raised in Point No.6 of RTI application by the appellant has also been clarified in detail.

6. In view of the above, no further cause of action is left in the matter. **The appeal case is disposed off and closed.** Copies of the order be sent to the concerned parties.

5. The PIO O/o Secretary, Regional Transport Authority, Hoshiarpur is issued show cause notice to explain his absence as also to explain as to why penalty should not be imposed in the instant case for not supplying the information to the appellant.
