## ORDER

The RTI application is dated 4.2.2020 vide which the complainant has sought information as enumerated in his RTI application. Complaint was filed in the Commission on 7.8.2020 under Section 18 of the Right to Information Act, 2005 (hereinafter called RTI Act). Notice of hearing was issued to the parties for today.

2. The appellant has sought the following information:-

3. ਪੰਚਾਇਤ ਵਲੋਂ ਖਾਲੀ ਕਰਾਏ 11 ਕਿਲਿਆਂ ਦੀ ਵੀਡਿਓ ਰਾਹੀਂ ਕਰਾਈ ਬੋਲੀ ਦੀ ਸੀ.ਡੀ. ਦਿੱਤੀ ਜਾਵੇ।”

3. The respondent-Public Information Officer has specifically replied to the appellant vide No. 12 dated 8.9.2020 to the complainant with a copy to the Commission. Regarding Point No. 1 the complainant states that the work(s) regarding grant of Rs.22 lacs is going on so the information cannot be supplied at this stage. With regarding to the information at Point No.2 of the RTI application the information is available on the website i.e. MGNREGA.COM and with regard to the Point No.3 of the RTI application, no C.D. is available regarding evacuation/auction of 11 acres of Panchayat land.

4. The Commission takes on record the reply of the respondent-Public Information Officer. Since, no more action is required to be taken in this case, the case is disposed of and closed.

## ORDER

The RTI application is dated 21.11.2019 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter called FAA) on 24.12.2019 and second appeal was filed in the Commission on 11.8.2020 under Section 19 of the Right to Information Act, 2005 (hereinafter called RTI Act). Notice of hearing was issued to the parties for today.

2. The appellant has sought the following information:-

“ਪੱਤਰ ਨੰ: 1/11/2019-4ਅ1/1595874/1 ਮਿੱਤੀ 14.10.2019 ਰਾਹੀਂ ਜਾਰੀ ਸੀਨੀਅਰ ਸਹਾਇਕਾਂ ਦੀ ਸੀਨੀਅਰਤਾ ਸੂਚੀ ਨਾਲ ਸਬੰਧਤ ਮਿਸਲ ਦੀ ਮੁਕੰਮਲ ਨੋਟਿੰਗ ਅਤੇ ਪੱਤਰ ਵਿਹਾਰ ਦੀ ਤਸਦੀਕ ਸੂਚਾ ਕਾਪੀ ਮੁਹੱਈਆ ਕਰਵਾਈ ਜਾਵੇ।”

3. The appellant states that no information has been provided by the respondents so far. Whereas a letter bearing No.8/34/2019/3e1/577 dated 16.9.2020 has been received from the respondents, which is taken on record. The representative of the respondents reiterated her reply already sent to the Commission and states that the said letter dated 14.10.2019 vide which the seniority list of Senior Assistants was circulated has been recalled on 31.10.2019 and it is no more in existence. She further states that the fresh seniority list of Senior Assistant is being circulated shortly and atleast 15 days will be given to all for objection(s), if any. She further requests to close the case accordingly.

4. As per the version of the representative of the respondents, the plea taken by the respondents is accepted till the final seniority list is circulated as it may not be in public interest at this stage. However, it is made clear that once the final seniority list of the Senior Assistant is circulated the complete information as has been sought by the appellant is liable to be supplied.

ORDER

This order may be read with reference to the previous order dated 4.9.2020.

2. The appellant states that no report/letter has been received from the respondents regarding compliance of Section 4 of the RTI Act in the office of the Naib Tehsildar, Kum Kalan. However, the representative of the respondents states that she is having the additional charge of the post of Naib Tehsildar, Kum Kalan due to the illness of the officer holding the regular charge of the post of Naib Tehsildar. With regard to the information she states that the compliance of Section 4 of the RTI Act has to be done by the office of the Deputy Commissioner, Ludhiana after combining/compiling of the data and it will be appropriate to get the details from the office of the Deputy Commissioner, District Ludhiana.

3. As per the statement given by the representative of the respondents, no action is required to be taken in this case. **However, the Deputy Commissioner, District Ludhiana is directed to make sure that the Section 4 of the RTI Act, 2005 is complied with.** With these directions, the case is disposed of and closed.
