ORDER

1. This order may be read with reference to the previous order dated 06.02.2019.
2. Appellant, Sh. Madan Lal states that supplied information is uncertified and incomplete information has been supplied to him by the respondent in connection with point no. 3 and 4. He pointed out that photographs missing from the supplied information as 12 photographs and 45 pages were sent by the Vigilance Bureau. He also added that supplied pages are not having page numbers. He submits his reply signed by him dated 16.03.2019 along with supporting documents, which are taken on record.
3. On this, respondent, Sh. Jaswinder Singh states that whatever information was available in the official record has already been supplied to the appellant. Nothing is left to be supplied.
4. After hearing both the parties and examining the case file, respondent PIO is directed to file an duly attested affidavit in connection with point no. 3 and 4 as per the RTI application of the appellant to put before the Commission on the next date of hearing along with directions to supply the certified copy of the supplied information and with page numbering before the next date of hearing positively. ORDER

1. The above mentioned case was last heard on 13.02.2019 and matter was fixed for further hearing on 20.03.2019, which was pre-poned and accordingly the case was fixed for hearing today.
2. Applicant, Sh. Jagmohan Singh Makkar is present with the self declaration in connection with Appeal Case No. 206 of 2013 along with information supplied to him in connection with the present case i.e. Appeal Case No. 1648 of 2015. He states that different information has been supplied to him on the same required information in two different cases.
3. Neither the respondent PIO is present for today's hearing nor did he file any reply in this regard.
4. After hearing the appellant and examining the case file, it is observed that respondent PIO was also absent on the previous hearing held on 13.02.2019 and he was directed to appear in person to represent this case. A copy of order dated 13.02.2019 along with copy of complaint by the appellant dated 31.08.2015 was sent to the respondent PIO by name through registered post. Hearing notice of pre-ponement was sent to the parties dated 26.02.2019.
5. In view of the above, the then respondent PIO, O/o Sub-Registrar, Hambra Road, Ludhiana (West) will **Show Cause** under Section 20 (1) of the RTI Act, as to why penalty be not imposed upon him for willful delay/denial in supplying the information to the RTI applicant and why the compensation be not awarded to the information-seeker under the provisions of the RTI Act, 2005.

In addition to his submission, the PIO is also hereby given an opportunity under Section 20(1) provision, thereto, for a personal hearing before the imposition of such penalty on the next date of hearing. A copy of this order to be sent to him through registered post along with RTI request.
