I have gone through letter no. 1215 dated17.03.2020 and it is submitted by the APIO that the appellant has not come present in the office of the PIO as was directed vide Order dated 26.02.2020.

So, the appellant is directed that he should visit the office of the PIO on 27.03.2020 at 10.00 AM and the PIO, Shri Taranjit Kaur Bajwa and the APIO, Smt. Jagdev Kaur both will be responsible to hear the appellant and resolve the matter involved in the RTI application and provide the relevant record to the appellant.

Treasury in the following heads and compliance report be sent back to the Commission:
