ORDER

1. This order may be read with reference to the order dated 23.02.2022 passed by this Bench on the previous hearing.
2. The case has been heard today. Shri Tejinder Singh, appellant comes present to attend the hearing through cisco webex. He states that he has not received any information so far.
3. The PIO O/o Sub Divisional Magistrate, Tarn Taran has neither come present in person nor through cisco webex nor he has deputed any of his representatives to attend the hearing on behalf of the PIO.

5. In addition to the written reply, the PIO is hereby given an opportunity u/s 20(1) proviso thereto for personal hearing before the imposition of such a penalty, on the next date of hearing. He may take note that in case he does not file the written reply and does not avail himself of the opportunity of personal hearing on the next date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceedings against him ex-parte.

6. The PIO is directed to supply information to the appellant before the next hearing as also to ensure to come present in person before the Bench on the next hearing.
