the submissions made by the respondent-Public Information Officer, there upon, is deliberated point wise, the details of which are as follows:-

- 1. With regard to Point No. 2 of the RTI application the appellant submitted that the copy of parvana sent to respondent dated 3.1.2019 is provided and the copy of statement of respondent dated 4.1.2019 is also provided which is now missing from the records during the tenure of Mr. Parvinder Singh Bhatti. However, the respondent-Public Information Officer shown the Commission during the hearing that the same exists in the record and no record is missing in this regard. He also states that nothing more is available on record pertaining to this point as has been sought by the appellant. According, the Commission observes that no further action is required in the matter.
- 2. With regard to Point No. 3 of the RTI application the appellant submits that the Public Information Officer has stated that Inspector Amarjit Singh was Inquiry Officer, but he (respondent-Public Information Officer) has failed to provide order of inquiry and inquiry report of inquiry conducted. In this connection, the respondent-Public Information Officer states that Sh. Amarjit Singh, the then Inspector was to conduct the inquiry who issued the notice the copy of which has already provided to the appellant in Point No. 2 of the RTI application. He also states that no written orders were issued to appoint Sh. Amarjit Singh as enquiry officer in this case. He further states that nothing more is available on record which could be supplied to the appellant with which the Commission is satisfied. Therefore, no directions can be issued to the respondent-Public Information Officer in this regard.
- 4. Regarding information pertaining to Point No. 4 of the RTI application the appellant has filed the rejoinder in which it has stated that no information has been supplied to him by the respondent-Public Information Officer. However, the respondent-Public Information Officer states that the information as available on record has already been supplied as supplied in Point No. 2 of the RTI application.
